In the future, officer positions will be voted on by the Junior Board. Will have President, Anna Miller, contact the other new officers so they can start meeting.
 - 2 Insurance for storage unit is included in our \$87/month rental (insurance is \$20/month).
 - 3 New banner is up with logo at the rink.

- 4 Consignment Sale - Secretary Lisa Kelley working on Consignment Sale for February. Original suggestion was one of last couple of weekends of February from 8-12 during Learn to Skate. She will also create an agreement for consignors and send to board for feedback. Asked if we should purchase racks and Lisa will look into cost to purchase. Advertising will take place by posters at rink, email to members and social media. Need to find out who has the Square account so we don't have to just take cash.
- 5 Website - Need website up and running. Do we have a domain? At this point, don't need payment aspects because we can use EntryEze.
- 6 Still need to re-visit the Bylaws!
- 7 Coach Sharon had baby. Gift to be sent on behalf of Club for about \$100-150. Jennifer Parker to purchase Spoonful of Comfort gift.
